

## Destination Management and Sustainable Tourism in Snohomish County

As tourism efforts transition from more of a focus on marketing to a strong balance between marketing and management, the DMO will foster and support:

- Ongoing coordination and collaboration among countywide tourism partners and interests, acting —as a central hub and umbrella management organization.
- >> Sustainable tourism and the implementation of environmentally-friendly practices which support Snohomish County's climate economy;
- >> Economic vitality and resiliency:
- >> Partnerships, inclusivity, and workforce development; and
- >> Protecting and enhancing the quality of life for Snohomish County residents.

As part of the revised Strategic Tourism Plan, Snohomish County will implement a "triple bottom line" approach that balances social and cultural values, environmental sustainability, and economic development. The triple bottom line philosophy considers the integral relationship of people, planet, and prosperity in decisions that impact tourism. See Figure 1.1. This approach will be critical for the future success of tourism across the county, offering multiple benefits:

- Supporting the quality of life of Snohomish County residents and creating memorable experiences for visitors.
- Promoting sustainable tourism initiatives that are environmentally friendly.
- Contributing to the economic vitality of the county and region.
